

**Regulation – 12-4 (iii) - the permissible period for retention of the residence**

iii) Death of the allottee - One Year (subject to regulation-10)	iii) Death of the allottee –Two Year on payment of normal Licence fees (subject to regulation-10)

This issues in pursuance to the decision taken by the Board of Directors, HPGCL in its 126<sup>th</sup> meeting held on 09.07.2021.


