The Governor of Haryana is pleased to enhance the Dearness Relief (DR) payable to State Government pensioners and family pensioners, who are drawing their pension/family pension as per 7<sup>th</sup> Pay Commission Pension Structure, from existing rate of 46% to 50% of the basic pension/family pension with effect from 1<sup>st</sup> January, 2024.

2. Enhanced DR shall be paid with the pension/family pension of March, 2024 payable in April, 2024 and arrear for the months of January, 2024 & February, 2024 shall be paid in the month of May, 2024. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
