Payment of Dearness Allowance to State Government employees, who are drawing their pay as per 7th Pay Commission Structure w.e.f. 1st July, 2023.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to State Government employees, who are drawing their pay as per 7th Pay Commission structure, from existing rate of 42% to 46% of the basic pay with effect from 1st July, 2023.

Enhanced DA shall be paid with the pay of October, 2023 and arrear for the months of 1st July, 2023 to 30th September, 2023 shall be paid in the month of December, 2023. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
