Subject:- Clarification regarding Reimbursement of Children Education Allowance for Children studying abroad.

I have been directed to invite your kind attention toward Finance Department's earlier instructions No. 4/5/2009-5FR (FD) dated 20.06.2018 and Rule 25 of HCS (Allowance to Government Employees) Rules, 2016.

It is hereby clarified that a government employee is entitled to draw Children Education Allowance which is capped at Rs. 1125/- per month as per FD's instructions dated 20.06.2018. There is no provision in HCS (allowance to Government Employees) Rules, 2016 which debar Haryana Government employees to claim Children Education Allowance for children studying abroad.

Hence, irrespective where the children are studying, if the certificate is produced that they are studying, this allowance will be provided for two children upto 10+2 level on production of self—attested affidavit by the Government employee subject to the other eligibility conditions contained in said Rule and instructions.
