Payment of Statutory Bonus to the employees of HPGCL for the FY 2021-22, under Payment of Bonus Act, 1965.

Haryana Power Generation Corporation Limited is pleased to sanction payment of statutory bonus @ 8.33% of the salary/wages to the eligible employees of the HPGCL for the FY 2021-22 in accordance with the provisions of the Payment of Bonus Act, 1965 as amended to date.

- 2. The ceiling limit with respect to salary /wages for employees to become eligible to earn bonus will remain maximum to Rs. 21,000/- (Rs. Twenty one thousand only) for the FY 2021-22.
- 3. The ceiling limit with respect to bonus to employees who are eligible to earn bonus will remain maximum to Rs. 7,000/- (Rs. Seven thousand only) for the FY 2021-22.
- 4. The employees shall be eligible for Bonus provided that he has worked in the establishment for not less than 30 working days in the year 2021-22 in accordance with the provision of Section 8 of the Payment of Bonus Act, 1965.
- 5. The payment of bonus to the deputationists will be regulated as per their terms and conditions of deputation.
- 6. It may be ensured that the payment of bonus for the year 2021-22 is invariably made before 30.11.2022, in accordance with the provisions of Section 19 of the Payment of Bonus Act, 1965.
- 7. The expenditure involved shall be debited to the Head 75.501- Statutory Bonus
