**No. G.S.R. 11/Const./Art.309/2018.**— In exercise of the powers conferred by the proviso to article 309 of Constitution of India, the Governor of Haryana hereby makes the following rules to further amend the Haryana compassionate Assistance to the Dependents of Deceased Government Employees rules, 2006, namely:-

1. (1) These rules may be called the Haryana Compassionate Assistance to the Dependents of Deceased Government Employees (Amendment) Rules, 2018.

(2) They shall be deemed to have come into force with effect from the 1st January, 2016.

2. In the Haryana Compassionate Assistance to the Dependents of Deceased Government Employees Rules, 2006, after rule 5, the following rule shall be inserted, namely:-

“5A. Revision of compassionate financial assistance.— The last pay received as compassionate financial assistance by the dependants of deceased Government employees, who died before the 1st January, 2016, shall be revised in accordance with the formula and procedure laid down in the Haryana Civil Services (Revised Pay) Rules, 2016 and the Haryana Civil Services (Assured Career Progression) Rules, 2016, as the case may be.”.


