Hon'ble High Court vide orders dated 09.08.2018 in LPA no. 1515 of 2015 has directed as under:-

- "For the purpose of accelerated 12½ % promotion to the post of Assistant Engineer as per amended Regulation 9(I)(b) (ii) of Punjab State Electricity Board Service of Engineers (Civil) Recruitment Regulations, 1965, as applicable to Haryana State Electricity Board, service of 5 years has to be counted from the date when Engineering Subordinate acquires A.M.I.E./B.E. Qualification.
- The ranking list shall be prepared for every year as on 1<sup>st</sup> January of every year in terms of clause 2 of Guidelines dated 20.10.1993 (Annexure-6P).
- The promotions shall be made strictly in accordance with the said ranking list.
- The department shall prepare such list within 3 months from the date of receipt of a certified copy of the order and the follow up action shall be taken by undoing the wrong promotions made and making promotions in terms of finding recorded above.**
- Order dated 16.3.2016 and 30.05.2016 passed by Single Bench are set aside and order dated 22.7.2015 is upheld with above noted modifications.
- All the contrary orders, guidelines or instructions so far as contrary to this judgment are quashed.

All the LPAs are accordingly disposed of.

Since the main cases have been decided, therefore, the pending CMs, if any, also stands disposed of."

2. In compliance to Hon'ble High Court Orders dated 09.08.2018 in LPA No. 1515 of 2015 alongwith connected cases, decision of Managing Directors Coordination Committee of HPUs dated 23.08.2022 and in pursuance to Ranking List of Engineering Subordinates issued by HVPNL on 26.07.2023 for the period 01.01.1988 to 14.08.1998, subsequent Ranking List issued by HPGCL on 16.10.2023 for the period 15.08.1998 to 17.08.2022, Seniority List for Assistant Engineers for the period 19.02.1988 to 14.08.1998 issued vide Order dated 16.08.2023 read with orders dated 31.01.2024, **the Tentative Revised Seniority List of Assistant Engineers/Electrical for the period 15.08.1998 to 31.12.2022 was issued on 19.01.2024.** A period of 21 days i.e. upto 08.02.2024 was given to concerned officers/officials/retirees to submit their legitimate grievances, if any. **After considering the legitimate grievances, the Revised Seniority List was circulated on 09.02.2024.**

3. Accordingly, in order to implement the orders of Hon'ble High Court in LPA 1515 of 2015 and to make room for seniors, in terms of Revised Seniority List dated 09.02.2024, the following changes in dates of promotion / reversions and deemed dates promotion/ reversion are hereby ordered as under:-

**A. Working Officers (Reversions):-** The following officers are hereby reverted with **immediate effect**, to the post of Assistant Executive Engineer (AEE) in compliance to Hon'ble High Court Orders in LPA 1515 of 2015 and to make room for their seniors as per Revised Seniority List dated 09.02.2024:-

**B. Retired Officers (Revision of status of retirees and their consequent re-fixation)**

- I. 
