2. I have been directed to invite your attention to the subject mentioned above and to state that the Government has decided to empanel the following new private hospitals for providing treatment to the Haryana Government employees/pensioners and their dependents:-

The above mentioned hospitals are empanelled on the terms and conditions mentioned below:-

1. To provide seamless and hassle free services to Haryana Govt. Employee/Pensioners and their dependents. The empanelled private hospitals shall extend all normal courtesies and facilitate the admission, treatment and discharge of Haryana Govt. beneficiaries with no delay or denial of medical facility.
2. A Nodal Officer shall be appointed at level of empanelled private hospital. The Nodal officer will communicate with the concerned nodal officer of the department in case of any grievance.
3. In case of any emergency/disasters /overflow of patients in Govt. Hospitals during epidemics, the empanelled hospitals will agree to share their ambulances, mortuary, ICU/CCU, burn unit, ward, beds, in need based manner.
4. All statutory Rules/Guidelines/Acts/Notifications issued by State Govt. from time to time (As already mentioned in the application form for New Empanelment Policy) shall be followed by the empanelled hospitals in true letters and spirit.
5. The hospitals will abide to all the National Programmes and its related IEC activities. The data needed for National Program or Health Indicators must be shared regularly with Health Department.
6. The hospitals shall follow the birth & death guidelines issued by the State Government from time to time. Any software developed by the Govt. will have to be adopted by the hospitals.
7. It will be the responsibility of the hospitals to provide renewed accreditation certificate before it's expiry as per Govt. Empanelment policy. If the hospital is unable to provide such certificate, the hospital will be de-empanelled automatically.
8. Guidelines already framed under State Govt. policy regarding reimbursement of medical bills dated 14-07-2020 now & as revised from time to time for empanelled hospitals shall be applicable. The empanelled hospitals shall abide to all the guidelines of Empanelment policy.
9. The empanelled hospitals will provide Limited Cashless Medical Facility notified by State Govt. Dated 20-11-2017, 04-04-2018, 08-03-2021 & 08-06-2021 amended from time to time.
10. The reimbursement on expenditure incurred on treatment taken in Entry Level NABH hospitals will be allowed on Entry Level NABH rates as per Haryana Govt. policy dated 14-07-2020.
11. The reimbursement on expenditure incurred on treatment taken in Full NABH hospitals will be allowed on NABH rates as per Haryana Govt. policy dated 14-07-2020.
12. The above listed Entry Level NABH Hospitals will remain empanelled for a period of one year subject to validity of accreditation certificate. The Entry Level NABH Hospitals will have to get full NABH accreditation within one year of empanelment failing which, these hospitals will automatically be de-empanelled without giving any prior notice.
13. The above listed Full NABH hospitals will remain empanelled for period of three years subject to validity of accreditation certificate. Thereafter, the hospitals will apply afresh.
14. Health Department reserves the right to call for record of treatment of any patient from any empanelled hospitals to ensure no mal-practice is being carried or for any others propose.
15. The hospital will charge Rs. 300/- once in month, as OPD Consultation fees from patients with chronic diseases, as per policy dated 14-07-2020.
16. The hospital will provide 40% discount in OPD Consultation fees to all Govt. employees, Pensioners and their dependents (without chronic diseases) as per policy dated 14-07-2020.
17. All empanelled hospitals will maintain record of the treatment of the patients.

18. Vide Govt. Policy dated 03-07-2019, if private empanelled hospitals gets disqualified/de-empanelled under "The Haryana Clinical Establishment(Registration and Regulation) Adoption Act, 2018" shall be automatically de-empanelled from the list of Haryana Govt. No. Separate intimation/notice shall be issued.

19. Vide Govt. Policy dated 03-07-2019, if private empanelled hospitals gets disqualified/de-empanelled under the list of services of "The Pradhan Mantri Jan Arogya Yojna (PMJAY) Ayushman Bharat Scheme, shall be automatically de-empanelled from the list of Haryana Govt.

20. The above mentioned multispecialty hospitals will install Oxygen Generation plant in their respective hospitals within six months of issuance of this letter.
