Subject: Regarding Sports Gradation Certificate to Eligible Sportsperson (ESP) for jobs in Haryana Government.

Memo:

Reference the letter No. 22/10/2013-1GS-III dated 6th April, 2018 issued by the Chief Secretary (General Services-III Branch) on the subject. The revised guidelines for the issue of Sports Gradation Certificate to Eligible Sportspersons (**ESP**) for jobs would be as under.

2. The gradation, eligibility for posts and sanctioning authority would be as per the Table below.

Sports Gradation Certificate	Eligibility for Jobs in Government	Sanctioning Authority
Grade-A	All posts	Director, Sports and District Sports & Youth Affairs Officer (of concerned district) jointly .
Grade-B	Posts, other than Group-A	
Grade-C	Posts, other than Group-A and Group-B	District Sports & Youth Affairs Officer (of concerned district).
Grade-D	Only Group-D post	

The sports gradation certificate signed by a lower official would be invalid. The sportsperson would submit the application in the prescribed form (in duplicate). The sanctioning authority would check the originals of all the supporting documents and retain one copy with all self-attested supporting documents in his official record. The certificate would be numbered serially and entered in a separate register maintained by the concerned DSYAO with running serial numbers.

3. Eligibility:

- i) The sportsperson plays for Haryana State at national level; or
- ii) The sportsperson is Haryana domicile and does not represent State/UT other than Haryana at national level.

4. Sports Disciplines Covered:

- i) Only those Sports/Games which are included in Haryana Sports Policy, as amended from time to time.
- ii) For international/Asian/Commonwealth tournaments, the individual/team should be sent/sponsored by Ministry of Sports & Youth Affairs or Sports Authority of India or National Level Sports Federation affiliated to Indian Olympic Association.

5. Category of Tournaments:

The tournaments are categorized in decreasing order of level of competitive difficulty as under:

6. Sports Gradation Certificate:

The sportsperson would qualify for the following Sports Gradation Certificate as per the following Table, subject to Rules 6.1, 6.2 and 6.3. The best sports achievement claimed by the sportsperson will be considered for issuing the sports gradation certificate.

Sports Gradation	Eligibility
Grade A	Participation in a tournament of Category 2 or above; or Medal winner in a tournament of Category 7 or above (restricted to Sports discipline played in Olympics/Paralympics).
Grade B	Participation in a tournament of Category 7 or above; or Medal winner in a tournament of Category 9 or above.
Grade C	Participation in a tournament of Category 9 or above; or Medal winner in a tournament of Category 11 or above (restricted to Sports discipline played in Olympics/Paralympics); or Medal winner in a tournament of Category 9 or above (other Sports disciplines)
Grade D	Participation in a tournament of Category 11 or above; or Medal winner in any listed Category.

Rule 6.1 In case of team game, the sportsperson should have been an active player, that is, he should have played in not less than 25% of the games played by the team in the tournament. A player kept as reserve shall not be considered as active player in that game. The sportsperson must show proof of having played at least one game (i.e., not kept as reserve) in the tournament.

Rule 6.2 The tournaments unless specifically indicated connotes senior level tournaments. The corresponding junior level tournament would be placed one category lower.

Illustration: The ISSF World Cup (Shooting) is at Category No. 5, hence the ISSF Junior World Cup is to be ranked one category lower at Category no. 6.

Rule 6.3 A sub-junior tournament is ineligible (except National School Games and Khelo India at Category No. 12).

7. **No appointment would be issued under the ESP quota without the Sports Gradation Certificate of the appropriate Grade issued by the competent authority in the new prescribed format.**

This issues with the advice of Chief Secretary to Government, Haryana, General Administration Department conveyed vide their U.O. No. 22/45/2018-1GS-III dated 26.04.2018, superseding their earlier instructions issued vide letter No. 12/44/88-2GSI dated 30th Nov. 1993.

Notification

No. 4/40/2017-4SYA.— In supersession of the instruction No. 12/44/88-2GSI dated 30th November, 1993 issued by Chief Secretary to Government of Haryana (General Administration Department), the Governor of Haryana hereby notifies the following guidelines for issuing Sports Gradation Certificate to the Eligible Sportsperson (ESP) for jobs under Sports quota and other purposes.

2. The Sports Gradation Certificate type, eligibility for jobs under Sports quota and the authority competent to sign and issue the Sports Gradation Certificate will be as follows:

Sports Gradation Certificate Type	Eligibility for Jobs under Sports quota	Authority competent to sign and issue Sports Gradation Certificate
Grade-A	All posts	Director, Sports and District Sports & Youth Affairs Officer (of concerned district) jointly.
Grade-B	Posts, other than Group-A	
Grade-C	Posts, other than Group-A and Group-B	District Sports & Youth Affairs Officer (of concerned district).
Grade-D	Only Group-D post	

The sportsperson may apply (in duplicate) to the District Sports & Youth Affairs Officer of the district concerned. The format of the application is at Schedule-1.

3. Eligibility:

- The sportsperson plays for Haryana State at national level; or
- The sportsperson is Haryana domicile and does not represent State/UT other than Haryana at national level.

4. Sports Disciplines Covered:

- Only those Sports/Games which are included in Haryana Sports Policy, as amended from time to time.
- For international/Asian/Commonwealth tournaments, the individual/team should be sent/sponsored by Ministry of Sports & Youth Affairs or Sports Authority of India or National Level Sports Federation affiliated to Indian Olympic Association.

The tournaments are categorized in decreasing order of level of competitive difficulty as per the following Table:

6. Sports Gradation Certificate:

A sportsperson is eligible for the following Sports Gradation Certificate Type as per following Table, subject to the conditions in Rules 6.1, 6.2 and 6.3. The best sports achievement claimed will be considered for issuing the sports gradation certificate.

Sports Gradation Certificate Type	Eligibility
Grade A	Participation in a tournament of Category 2 or above; or Medal winner in a tournament of Category 7 or above (restricted to Sports discipline played in Olympics/Paralympics).
Grade B	Participation in a tournament of Category 7 or above; or Medal winner in a tournament of Category 9 or above.
Grade C	Participation in a tournament of Category 9 or above; or Medal winner in a tournament of Category 11 or above (restricted to Sports discipline played in Olympics/Paralympics); or Medal winner in a tournament of Category 9 or above (other Sports disciplines)
Grade D	Participation in a tournament of Category 11 or above; or Medal winner in any listed Category.

Rule 6.1 In case of team game, the sportsperson should have been an active player, that is, he should have played in not less than 25% of the games played by the team in the tournament. A player kept as reserve shall not be considered as active player in that game. The sportsperson must show proof of having played at least one game (i.e., not kept as reserve) in the tournament.

Rule 6.2 The tournaments unless specifically indicated connotes senior level tournaments. The corresponding junior level tournament would be placed one category lower.

Illustration: The ISSF World Cup (Shooting) is at Category No. 5, hence the ISSF Junior World Cup is to be ranked one category lower at Category no. 6.

Rule 6.3 A sub-junior tournament is ineligible (except National School Games and Khelo India at Category No. 12).

7. Entitlement to any benefit under Sports quota:

An applicant is not entitled to any benefit, including appointment, under the Sports quota, unless supported by Sports Gradation Certificate of appropriate Grade in the format at Schedule-1.

संख्या-4/40/2017-4खे.यु.क.- भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, सरकार की विभिन्न सेवाओं में प्रतिभाशाली खिलाड़ियों की भर्ती तथा सेवा की शर्तों के लिए निम्नलिखित नियम बनाते हैं, अर्थात:-

1. (1) ये नियम हरियाणा प्रतिभाशाली खिलाड़ी (भर्ती तथा सेवा शर्तों) नियम, 2018 कहे जा सकते हैं। संक्षिप्त नाम, प्रारम्भ तथा लागूकरण।
(2) ये राजपत्र में इनके प्रकाशन की तिथि से लागू होंगे।
(3) ये सभी विभागों, सरकार द्वारा सारभूत रूप से वित्तपोषित या सरकार के नियन्त्रणाधीन बोर्डों, निगमों, प्राधिकरणों, आयोगों, अभिकरणों, विश्वविद्यालयों तथा अधिकरणों को लागू होंगे।
2. इन नियमों में, जब तक संदर्भ से अन्यथा अपेक्षित न हो,- परिभाषाएं।
(क) “विभाग” से अभिप्राय है, खेल तथा युवा कार्यक्रम विभाग, हरियाणा ;
(ख) “प्ररूप” से अभिप्राय है, इन नियमों से संलग्न प्ररूप ;
(ग) “सरकार” से अभिप्राय है हरियाणा राज्य की सरकार ;
(घ) “राष्ट्रीय खेल संघ” से अभिप्राय है, युवा कार्य तथा खेल मंत्रालय, भारत सरकार द्वारा सम्यक् रूप से मान्यता प्राप्त किसी संघ के रूप में ज्ञात या किसी अन्य नाम से पंजीकृत राष्ट्रीय स्तर खेल निकाय ;
(ङ) “अनुसूची” से अभिप्राय है, इन नियमों से संलग्न अनुसूची ;
(च) “राज्य” से अभिप्राय है, हरियाणा राज्य।
3. (1) विश्व चैम्पियनशिप, एशियन चैम्पियनशिप, कामनवैल्थ चैम्पियनशिप तथा विश्व विश्वविद्यालय क्रीडाओं के मामले में नियुक्ति के लिए विचारे जाने वाले खेल विषय उपनियम (2) तथा (3) में यथा उपबन्धित किये जाएंगे। सुविचारित किये जाने वाले खेल विषय।
(2) अनुसूची-I या अनुसूची-II की प्रवर्ग संख्या 2, 5क, 6क या 7क के अधीन नियुक्ति के लिए केवल ओलम्पिक खेलों में शामिल खेल विषय विचारे जाएंगे।
(3) या तो अनुसूची -I या अनुसूची-II की प्रवर्ग संख्या 5ख, 6ख या 7ख के अधीन नियुक्ति के लिए खेल विषय जो ओलम्पिक खेलों में शामिल नहीं हैं, किन्तु एशियन खेलों या कामनवैल्थ खेलों में शामिल हैं, विचारे जाएंगे।

भर्ती का ढंग।

4. (1) तत्समय लागू किसी अन्य नियम, पॉलिसी या हिदायत में दी गई किसी बात के होते हुए भी, उत्कृष्ट खिलाड़ी व्यक्तिगत खेल इवेंट के मामले में अनुसूची-I या टीम इवेंट के मामले में अनुसूची-II जो भी लागू हो के अनुसार वास्तविक पद पर नियुक्ति के लिए पात्र होगा:

परन्तु प्रतिभाशाली खिलाड़ी को इन नियमों के अधीन नियुक्ति के लिए तभी विचारा जाएगा यदि सुंसगत मैडल विजेता प्रदर्शन या भागीदारी, जैसी भी स्थिति हो, इन नियमों के प्रारम्भ से पूर्व अभिलिखित की गई थी।

(2) चार खिलाड़ियों तक को मिलाकर बनने वाली टीम के किसी सदस्य को अनुसूची-I के अधीन विचारा जाएगा। अनुसूची-II पांच या अधिक खिलाड़ियों से मिलाकर बनने वाली टीम के सदस्य को लागू होगी।

(3) अनुसूची-II के अधीन विचारण के लिए प्रतिभाशाली खिलाड़ी को उस खेल प्रतियोगिता में टीम द्वारा खेले गई क्रीडाओं के कम से कम पचास प्रतिशत क्रीडाएं खेले हुई होनी चाहिए।

(4) इन नियमों के अधीन नियुक्ति के विचारण के लिए केवल वरिष्ठ स्तर पर खेल आयोजन (इवेंट) को विचारा जाएगा।

आरक्षण।

5. इन नियमों के अधीन नियुक्तियां खिलाड़ियों के लिए आरक्षित रिक्तियों के विरुद्ध की जाएंगी। पैरा, नेत्रहीन, बधिर तथा विशेष ओलम्पिक खेलों के लिए नियुक्तियां निशक्त व्यक्तियों के लिए आरक्षित रिक्तियों के विरुद्ध की जाएंगी।

व्याख्या.— सरकार अपने विवेक पर खिलाड़ियों के लिए विशेष पद सृजित कर सकती है ताकि खेल कोटा के अधीन रिक्तियों की कमी इन नियमों के अधीन नियुक्तियों में बाधा न कर सके।

पात्रता मापदण्ड।

6. (1) प्रतिभाशाली खिलाड़ी भारत का नागरिक होना चाहिए।

(2) प्रतिभाशाली खिलाड़ी राष्ट्रीय स्तर पर या तो राज्य के लिए खेला हो या राज्य का अधिवासी/निवासी हो।

(3) खिलाड़ी जिसने राष्ट्रीय स्तर पर किसी अन्य राज्य या संघ राज्य क्षेत्र का प्रतिनिधित्व किया है इन नियमों के अधीन नियुक्ति के लिए पात्र नहीं होगा।

(4) खिलाड़ी वैध आवेदन की प्राप्ति की तिथि को पद पर नियुक्ति के लिए विनिर्दिष्ट न्यूनतम आयु से कम तथा पचास वर्ष से अधिक का नहीं होगा।

अपात्रता

7. (1) खिलाड़ी इन नियमों के अधीन नियुक्ति के लिए अपात्र होगा यदि उसने धन सम्बन्धी लाभ जैसे कि वाणिज्यिक समर्थन या व्यावसायिक खेल के लिए कोई अस्तित्वयुक्त संविदा की हो:

परन्तु भारत या राज्य या राष्ट्रीय खेल संघ के लिए खेलना व्यावसायिक खेल नहीं होगा।

No. 4/40/2017-4SYA.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules for recruitment and conditions of service of outstanding sportspersons in various services of the Government, namely:-

Short title,
commencement and
application.

1. (1) These Rules may be called the Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Rules, 2018.

(2) They shall come into force from the date of their publication in the Official Gazette.

(3) They shall apply to all Departments, Boards, Corporations, Authorities, Commissions, Agencies, Universities and Tribunals substantially funded by the Government or under the control of the Government.

Definitions.

2. In these rules, unless the context otherwise requires,-

(a) "Department" means the Sports and Youth Affairs Department, Haryana;

(b) "Form" means a form appended to these rules;

(c) "Government" means the Government of the State of Haryana;

(d) "National Sports Federation" means a registered national level sports body, known as a Federation or in any other name, duly recognized by the Ministry of Youth Affairs and Sports, Government of India;

(e) "Schedule" means a Schedule appended to these rules;

(f) "State" means the State of Haryana.

Sports disciplines to
be considered.

3. (1) Sports disciplines to be considered for appointment in the case of World Championship, Asian Championship, Commonwealth Championship and World University Games shall be as provided under sub-rules (2) and (3).

(2) Sports disciplines included in Olympic Games only shall be considered for appointment under category numbers 2, 5A, 6A or 7A of either Schedule-I or Schedule-II.

(3) Sports disciplines not included in Olympic Games, but included in either Asian Games or Commonwealth Games, shall be considered for appointment under category numbers 5B, 6B or 7B of either Schedule-I or Schedule-II.

Method of
recruitment.

4. (1) Notwithstanding anything contained in any other rule, policy or instruction for the time being in force, an outstanding sportsperson shall be eligible to be appointed to a post strictly as per Schedule-I in case of an individual event or Schedule-II in case of a team event, whichever is applicable:

Provided that an outstanding sportsperson shall be considered for appointment under these rules even if the relevant medal winning performance or participation, as the case may be, was recorded prior to the commencement of these rules.

(2) A member of a team consisting of upto four players shall be considered under Schedule-I. The Schedule-II shall apply for a member of a team consisting of five or more players.

(3) For consideration under Schedule-II, the outstanding sportsperson must have played in not less than fifty percent of the games played by the team in that tournament.

(4) For consideration of appointment under these rules, only sports events at senior level shall be considered.

Reservation.

5. Appointments under these rules shall be made against the vacancies reserved for sportspersons. For Para, Blind, Deaf and Special Olympic Sports, the appointments shall be made against vacancies reserved for Persons with Disabilities.

Explanation.— The Government may at its discretion create special posts for sportspersons so that the lack of vacancies under the sports quota is not an impediment to the appointments under these Rules.

- 6.** (1) The outstanding sportsperson must be a citizen of India. Eligibility criteria.
 (2) The outstanding sportsperson must have either played for the State at the national level or be a domicile/resident of the State.
 (3) A sportsperson who has represented any other State or Union Territory at the national level shall not be eligible for appointment under these rules.
 (4) The age of the sportsperson shall not be less than the minimum age specified for appointment to the post and not above fifty years on the date of receipt of valid application.
- 7.** (1) A sportsperson shall be ineligible for appointment under these rules in case he has any subsisting contract for pecuniary gains like commercial endorsement or professional sport: Ineligibility.
 Provided that playing for India or State or National Sports Federation shall not be professional sport.
 (2) A sportsperson shall be ineligible for appointment under these rules if he is guilty of sports related misconduct like doping, sexual harassment and abuse, competitive manipulation like betting, inside information, match fixing, tanking threatening the integrity and essence of sports.
 (3) In case a person appointed under these rules is found guilty of any such sports related misconduct at any time subsequent to his appointment, his service shall be terminated immediately.
- 8.** (1) Essential qualifications or experience prescribed for the post in the service rules of the appointing Department, other than qualification of a technical or professional nature like law, medicine, engineering, architecture etc., shall not be applicable at the time of the initial appointment. The appointee shall, however, be required to obtain such essential qualification(s) and complete such specific course(s) or training(s) within the probation period, which is considered essential by the appointing Department to discharge the responsibilities meant for the job. Qualification.
 (2) An outstanding sportsperson so appointed shall be required to pass all prescribed tests at par with other categories of appointees before confirmation in service.
- 9.** (1) An eligible sportsperson shall submit an application in Form-I for individual event and in Form-II in case of team event along with proof of outstanding sports achievement, date of birth, eligibility etc. and forwarded by the National Sports Federation recognized, duly signed by the President or Secretary General of the National Sports Federation, to the Department. Procedure for appointment.
 (2) The Department shall recommend to the office of Chief Secretary, the appropriate category of job after verification of original documents within thirty days of the receipt of application from the sportsperson. The Chief Secretary shall forward the application to the concerned Department where vacancy is available for appointment of the sportsperson.
 (3) The initial appointments whether in Haryana Civil Service, Haryana Police Service or any other Group A, B or C posts shall be made with the word "Sports" in parenthesis that shall be dropped only upon obtaining the essential qualification which may be prescribed by the appointing Department as per sub-rule (1) of rule 8.
 (4) Unless the word "Sports" is dropped from the order of appointment as per the provisions of sub-rule (3), all postings shall be within a separate sports cadre for promoting sports, carrying such prospects of career progression as may be specified by the Department.
 (5) In case an appointee is unable to complete the prescribed course and training successfully, the probation period shall automatically be deemed to have been extended.
- 10.** The Department may at any time utilize the services of such appointees for promoting sports. Discretionary power of Department.
- 11.** (1) Notwithstanding anything inconsistent contained in any service rules framed under the proviso to article 309 of the Constitution of India, the provisions of these rules shall prevail. Overriding effect.
 (2) The policy issued *vide* notification No. Sports-Estt-DA-I-2014/23501-23555, dated the 15th July, 2014 is hereby rescinded:
 Provided that a sportsperson whose application is pending under the said policy on the date of notification of these Rules shall be eligible to apply under these rules and his previous application shall not be considered.

6. Sports Gradation Certificate:

A sportsperson is eligible for the following Sports Gradation Certificate Type as per the following Table, subject to the conditions in Rules 6.1, 6.2 and 6.3. The best sports achievement claimed by the sportsperson will be considered for issuing the sports gradation certificate.

Sports Gradation Certificate Type	Eligibility
Grade A	Participation in a tournament of Category 1 or 2; or Medal winner in a tournament of Category 1 to 7.
Grade B	Participation in a tournament of Category 3 to 7; or Medal winner in a tournament of Category 8 or 9.

Sports Gradation Certificate Type	Eligibility
Grade C	Participation in a tournament of Category 8 or 9; or Medal winner in a tournament of Category 10 or 11 .
Grade D	Participation in a tournament of Category 10 or 11; or Medal winner in a tournament of Category 12 or 13.

Rule 6.1 In case of team game, the sportsperson should have been an active player, that is, he/she should have played in not less than 25% of the games played by the team in the tournament. A player kept as reserve shall not be considered as active player in that game. The sportsperson must show proof of having played at least one game (that is, not kept as reserve) in the tournament.

Rule 6.2 The tournaments unless specifically indicated connotes senior level tournaments. The corresponding junior level tournament would be placed one category lower.

Illustration: If a World Cup is placed at category no. 5, the corresponding Junior World Cup will be placed one category lower, that is, category no. 6.

Rule 6.3 A sub-junior/youth tournament is ineligible, except those specifically listed in the table at serial number 5 above.

- हरियाणा प्रतिभाशाली खिलाड़ी (भर्ती तथा सेवा शर्तों) नियम, 2018 (जिन्हें, इसमें, इसके बाद, उक्त नियम कहा गया है) में, नियम 3 के स्थान पर, निम्नलिखित नियम प्रतिस्थापित किया जाएगा, अर्थात् :-

No. 4/40/2017-4SYA.— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules, further to amend the Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Rules, 2018, namely:-

1. (1) These rules may be called the Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Amendment Rules, 2019.

(2) These rules shall be deemed to have come into force from the 5th September, 2018.

2. In the Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Rules, 2018 (hereinafter called the said rules), for rule 3, the following rule shall be substituted, namely:-

“3. Sports events to be considered.- (1) Sports events to be considered for appointment in the case of World Championship, Asian Championship, Commonwealth Championship and World University Games shall be as provided under sub-rule (2) and (3).

(2) Sports events included in the immediate next Olympic Games only shall be considered for appointment under category numbers 2, 5A, 6A or 7A of either Schedule-I or Schedule-II.

(3) Sports events not included in the immediate next Olympic Games, but included in either the immediate next Asian Games or the immediate next Commonwealth Games, shall be considered for appointment under category numbers 5B, 6B or 7B of either Schedule-I or Schedule-II.

3. In the said rules, in rule 4, in sub-rule (3), for the word “games”, the word “matches” shall be substituted.
4. In the said rules, in rule 6, for sub-rule (2), the following sub-rule shall be substituted, namely :-

“(2) The outstanding sportsperson must have either played for the State at the national level throughout or be a domicile/resident of the State.”
5. In the said rules, in rule 9, in sub-rule 4, for the word “Department” existing at the end, the word “appointing Department” shall be substituted.
6. In the said rules, in Schedule-I,-
 - (i) under heading “Participant”, under column “Quarter Finals or above”, against category number 4 for the “Nil” entry, the following entry shall be substituted, namely :- “Group C”, and
 - (ii) for the entry “Group B” wherever occurring the following entry shall be substituted, namely:- “Group B (other than Haryana Police Service)”.
 - (iii) the abbreviation “HCS” means “Haryana Civil Service (Executive Branch)”.
 - (iv) the abbreviation “HPS” means “Haryana Police Service”.
7. In the said rules, in Schedule-II,
 - (i) for the entry “Group B” wherever occurring, the following entry shall be substituted, namely:- “Group-B (other than Haryana Police Service)”.
 - (ii) the abbreviation “HCS” means “Haryana Civil Service (Executive Branch)”.
 - (iii) the abbreviation “HPS” means “Haryana Police Service”.
8. In the said rules, in Form-I, for the entry against serial number 11, for the words “Sports Discipline”, the words “Sports Event” shall be substituted.
9. In the said rules, in Form-II,-
 - (i) for the entry against serial number 11, for the words “Sports Discipline”, the words “Sports Event” shall be substituted, and
 - (ii) in sub-clause (viii) and (ix) of serial number 12, for the word “games”, the word “matches” shall be substituted.

Subject: Regarding reservation in jobs for sports persons for each of Group-A, B, C and D.

Sir,

I am directed to invite your attention to the subject noted above and to say that Sports and Youth Affairs Department has in supersession of Government letter No. 12/44/88-2GS-1, dated 30-11-1993 notified the guidelines for issuing sports gradation certificate and eligibility criteria to Eligible Sports Person (ESP) for jobs under sports quota and other purpose vide notification No. 4/40/2017-4SYA, dated 25.5.2018. The Sports and Youth Affairs Department has also notified the "Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Rules, 2018" on 05.09.2018.

2. After enactment of "Haryana Outstanding Sportspersons (Recruitment and Conditions of Service) Rules, 2018" and notification for sports gradation certificate and eligibility criteria, the General Administration Department's instructions No.22/10/2013-IGSIII, dated 06.04.2018 on the same subject have become redundant w.e.f, notification of the ibid Rules.

3. Keeping the above in view, the State Government has decided to withdraw the instruction No. 22/10/2013-IGSIII, dated 06.4.2018. Further, the State Government has decided that in supersession of all other relevant instructions No. 22/10/2013-IGSIII, dated 15.07.2014, No. 22/10/2013-IGSIII, dated 27.03.2017 and instructions No. 22/10/2013-IGSIII, dated 06.06.2018 in respect of reservation for Eligible Sports Persons (ESPs), the following is issued:-

Continue -2-

4. The quantum of reservation for Eligible Sports Person (ESP) in direct recruitment in respect of posts of Group A, B and C will continue to be 3%. In respect of Group D posts it shall be 10%.

4 (a) The 3% reservation for Eligible Sports Person (ESP) in Group A and B posts will be compartmentalized horizontal reservation between Un-reserved/General, Scheduled Castes and Backward Classes categories as under:-

Sr. No.	Category	Quantum reservation	Roster points
(i)	ESP(SC)	1%	34
(ii)	ESP(BC'A & B')	1%	56 in the first Block of 100 posts and 96 in the next block of 100 posts
(iii)	ESP (Un-reserved/General)	1%	91

4 (b) The 3% reservation for Eligible Sports Person (ESP) in Group C posts will be compartmentalized horizontal reservation between Un-reserved/General, Scheduled Castes and Backward Classes categories as under:

(ii)	ESP(BC'A & B')	1%	32 in the first Block of 100 posts and 63 in the next block of 100 posts

4(c) The 10% reservation for Eligible Sports Person(ESP) in Group D posts will be compartmentalized horizontal reservation between Un-reserved/General, Scheduled Castes and Backward Classes categories as under:

5. In case, there remains a shortfall in any of the compartmentalized groups mentioned above, the same can be filled during the same recruitment from the other compartmentalized group and vice versa i.e. in case the vacancy remains unfilled in ESP (SC), same can be filled from ESP (Un-reserved/General) or any other group as per availability and merit of the eligible candidate(s), so that the 3% quota for Group A,B, C and 10% quota for Eligible Sports Person can be filled.


