Subject:- Clarification regarding regulations for the Haryana State Subordinate Accounts Services (HSAS) Examination (Ordinary Branch), 2021.

Sir,

I am directed to invite your kind attention to this department letter No. 14/30/2021-1FA, dated 16.07.2021 on the subject cited above. The word (Section IX only) after XII was typed inadvertently in column No. 4. at serial No. 5 in the subject namely "audit and Financial Regulations" syllabus for Part-I Examination in Annexure-I of the Regulations. Now the Government has decided to delete the word "(Section IX only) after XII" as the section IX does not exist in chapter XII of P.F.R. Vol. I.

Further, the candidates who are found using unfair means during the HSAS examination, his/her candidature for this examination will be cancelled and he/she will also be debarred for appearing in the next attempt of the HSAS examination.

In addition to the above, Government has clarified the definition of Statutory Body/Autonomous Body is as under: -

- (i) That has been created under a Statute/Act of a State/Central Government ; and
 - (ii) Is finalized wholly or substantially from the cess or Central/State Government grants.
- "Substantially" means that more than 50% of the expenditure of the autonomous bodies is through cess or Central/State Government grants.

Explanation: A State Autonomous Bodies includes a State University but does not include a Public Sector Undertaking/Public Enterprise/Company registered under the Companies Act/Society registered under the Societies Registration Act/ and private bodies and managements."

You are therefore requested to bring this to the notice of all the employees who intend to appear in this examination.
