Sub: Notification of Departmental Accounts Examination for Engineering Officers & Subordinates to be conducted on outsourced basis through UIAMS, Panjab University, Chandigarh for Haryana Power Utilities.

It is to inform that as per Memorandum of Understanding (MoU) signed on dated 05.08.2013 between UIAMS, Panjab University, Chandigarh & HVPN Power Training Institute and this office order No.56/HPTI-344 dated 12.02.2020, the Departmental Accounts Examination for Engineering Officers & Subordinates was to be conducted by UIAMS, Panjab University, Chandigarh tentatively in the month of March/ April, 2021. But due to Covid-19 Pandemic Departmental Accounts Examination for Engineering Officers & Subordinates could not be conducted.

Accordingly, applications forms of all the eligible candidates including mercy chance holder were asked through controlling officers of the concerned power utility. Out of these applications forms only 464 No. forms were found in order in all respect. The copy of names of 464 No. officers/official is attached herewith for your information. If any correction is required in the list attached same will be done by the controlling officers and submit the same to this office at the earliest.

It is again requested to issue necessary directions to the concerned controlling officers for arranging the applications forms of the eligible candidates who are willing to appear in the Departmental Accounts Examination for Engineering officers & subordinates in addition to above 464 No. officers/official (as per List attached).

Now, UIAMS, Panjab University, Chandigarh has proposed to conduct Departmental Accounts Examination for Engineering Officers & Subordinates tentatively in the month of September, 2021.


Therefore, it is requested to issue necessary directions to the concerned officers for arranging application forms of the eligible candidates if any who intend to appear in Departmental Accounts Examination for Engineering Officers & Subordinates. The particulars given by the candidates in his/ her application as per prescribed Performa be got verified from their service records by the Competent Authority (CGM-Admin/ CE OP UHBVN , Panchkula, CE PD & C, Panchkula, SE-Admin-I & II/HVPNL, UHBVNL/HPGCL/DHBVNL). The application forms complete in all respect of eligible candidates along with soft copy of list of total candidates may kindly be sent to this office through Cadre Controlling Authority, latest by 20.08.2021, so as to enable this office to forward the same to Panjab University well in time.

Moreover the important information regarding the Departmental Accounts Examination is as under:-

1. Supply the list of 464 No. officers/officials with correction, if any by the concerned utility upto 20.08.2021.
2. Last date of submission of application forms of remaining candidates is 20.08.2021 and no application will be accepted after last date.
3. The applications on the prescribed Performa (Annexure-I) received through Cadre Controlling Authority/ Competent Authority (CGM-Admin/ CE OP UHBVN , Panchkula, CE PD & C, Panchkula, SE-Admin-I & II/HVPNL, CAO/UHBVNL/HPGCL/DHBVNL) shall only be accepted and applications sent directly to this office will be rejected straightway without any communication/ back reference.
4. Roll Number and Date sheet of the candidates will be supplied subsequently.
5. Registration is mandatory for appearing in Departmental Accounts Examination of all candidates. If any candidate fails to provide registration number in application form, Roll No. will not be issued. However, if candidate is applying first time for Departmental Accounts Examination or not apply till date, then in addition to application form for appearing in Departmental Accounts Examination, candidate have to submit duly filled up and signed application form (Annexure-II) with registration application form (Annexure-III) along with supportive documents and two attested passport size photographs to this office immediately through Cadre Controlling Authority/ Competent Authority (CGM-Admin/ CE OP UHBVN , Panchkula, CE PD & C, Panchkula, SE-Admin-I & II/HVPNL, CAO/UHBVNL/HPGCL/DHBVNL).
