The rules governing above reimbursement/entitlement are as below:

- a) The driver will submit their bill of mobile handsets & monthly bills to their outsourcing agency & then outsourcing agency will forward duly verified and approved bills to the HPGCL for payment.
- b) The outsourced drivers permitted to purchase the mobile phone at prices higher than the permissible/entitled limits, subject to re-imbursement restricted to permissible limits.
- The replacement of mobile phone be allowed only after completion of two years c) from the date of earlier purchase of mobile phone.
- If any contractual driver leaves the job then he will hand over the mobile to the d) outsourcing agency & agency will hand over the mobile to newly deputed driver. However, if any post of driver stands terminated then driver allowed to retain the phone on deposition of residual value to department which is worked out as under:
