

Subject: Age for entry into Government service or to compete for regular recruitment and relaxation in age under various circumstances.

Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that Government has decided to issue consolidated instructions in supersession of all the instructions already issued by Government regarding fixation of lower and upper age limit for entry into Government service or to compete for regular recruitment and also regarding grant of relaxation in upper age limit under various circumstances (previous instructions that are superseded are listed at Annexure-A).

2. Government has considered the matter and decided as below:
- i) The minimum age of a person for entry into Government service shall be 18 years and maximum age shall be 42 years in respect of the posts of all Groups A, B, C & D in addition to the age relaxation prescribed herein for various categories.
 - ii) Age relaxation for various categories is as under:-

Sr. No.	Categories where relaxation is admissible	No. of years of relaxation
(i)	Scheduled Castes/Scheduled Tribes.	5 years
(ii)	Backward Classes.	5 years
(iii)	Wives of military personnel who are disabled while in military service.	5 years
(iv)	Widowed or legally divorced women provided she has not remarried.	5 years

(v) Judicially separated women residing separately for more than two years from the date as prescribed for the purpose of age for candidates of other categories.	5 years
(vi) Unmarried women.	5 years
(vii) Ex-serviceman*	<p>to the extent of his military service added by three years provided—</p> <p>(a) he has rendered continuous military service for a period of not less than six months before his release; and</p> <p>(b) he was released otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.</p>
(viii) Disabled persons who covered under the Rights of Persons with Disabilities Act, 2016.	<p>(i) 10 years (+5 years if candidates belongs to S/Caste, S/Tribe, B/Classes) subject to maximum 55 years, for all posts of Group C & D, and also for Group A & B posts where recruitment is made otherwise than through open competitive examination.</p> <p>(ii) 5 years (+5 years if candidates belongs to S/Caste, S/Tribe, B/Classes) subject to maximum 55 years for Group A & B posts where recruitment is made through open competitive examination.</p> <p>Note.— Relaxation in age limit shall be applicable irrespective of the fact whether the post is reserved or not, provided the post is identified suitable for persons with disabilities.</p>
(ix) Persons who have already worked or presently working on adhoc/contract/work-charged/ daily wages basis	<p>Equal to the period of experience on adhoc/ contract/work-charged/ daily wages basis excluding the period of break, if any, subject to attaining the maximum age of 55 years.</p>



(x)	Posts of Police Personnel and Prisons Personnel (e.g. Constable, ASI, and above) where upper age limit is less than 42 years.	5 years to S/Caste, S/Tribe, B/Classes & candidates of EWS only.

*For Ex-serviceman: For appointment of an ex-serviceman to a post of Group A, B, C or D, his/her age will be calculated keeping in view the actual age minus (actual period of military service plus three years). If the resultant age does not exceed the maximum age limit prescribed for the post for which he/she is seeking appointment he/she shall be deemed to satisfy the condition regarding age limit.

3. Until necessary amendment is made in the rules by the Finance Department, these instructions shall be applicable with immediate effect instead of the provision which exists in Rule 22 of the Haryana Civil Services (General) Rules, 2016.


