संख्या 1/15/2024-1 पेंशन.— भारत के संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (पेंशन) नियम, 2016 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:-

- (1) ये नियम हरियाणा सिविल सेवा (पेंशन) संशोधन नियम, 2025 कहे जा सकते हैं।
 - (2) ये 19 जुलाई, 2016 से लागू हुए समझे जाएंगे।
2. हरियाणा सिविल सेवा (पेंशन) नियम, 2016 में नियम 95 में उपनियम (2) के स्थान पर, निम्नलिखित उप नियम प्रतिस्थापित किया जाएगा, अर्थात्:-

"(2) सेवानिवृत्ति पर इस प्रकार संसारीकृत पेंशन के भाग को उसकी सेवानिवृत्ति की तिथि से 15 (पन्द्रह) वर्ष पूर्ण होने पर बहाल कर दिया जाएगा"।

Notification

The 2nd July, 2025

No. 1/15/2024-1 Pension(FD).— In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules, further to amend the Haryana Civil Services (Pension) Rules, 2016, namely:—

1. (1) These rules may be called the Haryana Civil Service (Pension) Amendment Rules, 2025.
(2) They shall be deemed to have come into force with effect from the 19th July, 2016.
2. In the Haryana Civil Services (Pension) Rules, 2016, in rule 95, for sub-rule (2), the following sub rule shall be substituted, namely:-

“(2) The fraction of pension so commuted on retirement shall, however, be restored to him on completion of 15 (fifteen) years from the date of retirement”.
