

Please refer to on the subject noted above.

There is surge in cases of Covid-19 and the OPD of PGI Chandigarh, Govt.Hospital/Govt. approved hospital are not functioning to full extent. In view of this the patient of HPUs who are on regular treatment for Chronic disease may be allowed to purchase medicine and allowed to get annual investigation disease related relevant investigations done on existing prescription without getting it repeated from Govt. Hospital,/Govt. approved hospital/Power Utility Health Centers for the period of 3 months i.e. till 31.03.2022. However, the patient are advised if possible to avail teleconsultation facility to titrate the dose of drugs. Earlier the date was fixed upto 31.12.2021 for purchase of medicines for chronic disease on existing prescription.
